OFFICIAL RULES**

4. Timing

The Sweepstakes begins on September 15, 2016 at 8:00 PM Eastern Time ("ET") and ends on September 15, 2016 at 8:57 PM ET ("Sweepstakes Period") and consist of four (4) entry periods ("Entry Period" and collectively "Entry Periods"). Entry Periods will be based on the allotted response times indicated in the Entry Periods table in section 6 of these Official Rules. Administrators are the official timekeepers for the Sweepstakes.

5. How to Enter

To enter you must follow the @SarahScoop and @Walgreens Twitter accounts on www.Twitter.com/SarahScoop, and www.Twitter.com/Walgreens and tweet the hashtag #StarbucksRefreshers and #WIN on each of your tweets during the Sweepstakes Period. Online entries will be deemed submitted by the authorized account holder of Twitter account submitted at time of entry. By entering, you agree to be bound by these Official Rules.

Entry Limits: Limit five entries per person, per household, per Entry Period (for a total of up to twenty [20] entries) during the Sweepstakes Period. Duplicate or multiple online entries from the same person/Twitter handle or the same person using different email addresses/Twitter handles per Entry Period are not permitted and will be automatically eliminated. Entries are only considered qualified entries during the Entry Period for which it was submitted and will not roll over into subsequent Entry Periods. Potential winners will be notified by a winner announcement tweet and asked to send a Twitter Direct Message (“DM”) to confirm on September 15, 2016. You must follow @SarahScoop and @Walgreens on Twitter in order to respond via DM to verify eligibility and shipping information for claiming prizes.
